THIS IS A PERMIT TO BE A HUMAN BEING IN ANY COUNTRY . THIS PERMIT OVERRIDES ANY OTHER GOVERNMENT OR COUNCIL LICENCE OR PERMIT ANY WHERE ANY TIME.

A PERMIT IS ANOTHER WORD FOR PERMISSION. THIS PERMIT ENTITLES THIS HUMAN BEING TO DO WHAT HUMAN BEINGS DO AND HAVE DONE LEGALLY FOR CENTURIES WITHOUT ANY GOVERNMENT OR CORPORATE PERMISSION

THIS PERSON HAS BEEN APPROVED AS BEING A HUMAN BEING AND AUTHORIZED TO CARRY OUT NATURAL NON THREATENING HUMAN BEING BEHAVIOURS.

THIS HUMAN BEING ALSO **UNDER COMMON LAW**

THE CHARTER OF HUMAN RIGHTS

THE GENEVA CONVENTION

HAS THE FOLLOWING RIGHTS

PRIMARY RIGHTS

1A. TO ALERT THEIR FELLOW HUMAN BEINGS WHEN BEING A DIRECT WITNESS TO THE CRIMINAL ACTIVITIES OF NON HUMAN BEINGS SECRETLY WORKING FOR A CRIMINAL GOVERNMENT ENTITY WHICH IS COMMITTING EXTREME ATROCITIES AND/OR ASSASSINATIONS AND PURPORTING TO GET AWAY WITH THEM BY USING THEIR CONNECTIONS AND INFLUENCE TO OBFUSCATE THE EVIDENCE

1B. IN THE ABOVE CASE WHEN AN ASSASSINATION HAS FAILED TO BE COVERED UP PROPERLY IN THE TIME HONOURED FASHION, THAT THE PERPETRATOR GRACIOUSLY ACCEPTS THAT THEY HAVE FAILED AS A HUMAN BEING, TAKE THE LIFE PRISON SENTENCE THEY DESERVE AND LEARN THE LESSON THAT NO ONE HAS THE RIGHT TO ASSASSINATE AN INNOCENT PERSON AT THE BEHEST OF ANOTHER WORLD LEADER NO MATTER HOW MUCH WEALTH THEY POSSESS.

2. TO DISAGREE WITH GOVERNMENT AND CORPORATE POLICY WITHOUT BEING THREATENED OR LABELLED A TERRORIST, A CONSPIRACY THEORIST OR MENTALLY UNSTABLE.

3. TO FIGHT UNDER HUMAN RIGHTS/WAR CRIME LAWS TO GET THE SAID CRIMINALS IMPRISONED FOR THEIR ACTIVITIES, REGARDLESS OF WHO THEY ARE CONNECTED WITH IN THE (CRIMINAL) GOVERNMENT

4. TO FIGHT FOR RESTITUTION OF STOLEN PROPERTY, MONEY AND TIME BASED COMPENSATION WHICH HAS BEEN TAKEN FROM THEM IN CONJUNCTION WITH ANY OF THE ABOVE ATROCITIES

5. TO NOT BE BOMBARDED WITH ELITIST/NWO PROPAGANDA ABOUT CONTRIBUTING TO SOCIETY AND PROVIDING VALUE FROM PEOPLE WHO PROVIDE NONE OF THE SAME THEMSELVES AND INSTEAD ARE AMONGST THE MOST CORRUPT/CRIMINAL/PARASITIC AND DUPLICITOUS PEOPLE ON THE PLANET

OTHER RIGHTS:

6. TO NOT HAVE THEIR LIVES DISMANTLED BY GOVERNMENT CRIMINALS USING EXTREME SURVEILLANCE TECHNOLOGY WHICH MUTATES THE REALITY OF THEIR DAY TO DAY ACTIVITIES BY REMOTE CONTROL USING EXTREME SURVEILLANCE TECHNOLOGY, OR BE MANIPULATED AND/OR ABUSED PHYSICALLY AND PSYCHOLOGICALLY BY GROUPS OF MARAUDING CRIMINAL SPIES

7. TO TRAVEL ON PUBLIC ROADS AND HIGHWAYS FREELY (WITHOUT A DEMAND FOR IDENTIFICATION OR DEMAND FOR MONEY)

8. TO SPEAK SING DANCE AND PLAY AN INSTRUMENT IN PUBLIC

9. TO USE A VEHICLE (CAR OR BOAT) OWNED OR OWNER PERMISSION GIVEN
